

I refer to the Government's recent plans of the Western Sydney Aerotropolis Airport area.

I have grown up in the Rossmore area. This is my parents land and home which they are now retired and elderly. They have lived on this land for the past

The government has classified a part of their land as 'non-urban'.

My parents purchased this property knowing it was a 1in 100 year flood, but a small portion of their land was considered flood zone.

According to the Government's plans that was released, it seems to be more land than anticipated that is now deemed 'non-urban land'.

I have seen my parents work hard to pay this land off. They pay their taxes and also, in the past few years, the council rates have sky rocketed.

We are aware that the airport is coming and our areas are required for development. However I am concerned that my parents, and other residents that are affected by the 'non-urban land', will be short changed.

Where are they all supposed to go that is close by? My parents love the rural lifestyle. My father has his own vegetable farm and fruit trees, which is enough to keep him going. It's probably what keeps him out of the nursing homes.

Their doctor is close by and the facilities that they are used to, are all close by too. They will need to go further out to find a bit of land and be further away from their doctor, the facilities and their friends.

My brother lives nearby and help look after my parents as well. However, once my parents are forced to move out, we will all not be close by. We are a close family and help each other where we can.

All we ask is that they be compensated fairly to be able to afford land similar to what they currently have and to be treated with respect. How can we all be treated differently?

Is this the Australian way on how you treat us? We need answers as to what will happen.

My parents don't know where to go and would like to move to another rural lifestyle but will need to go out further, which will be too far.

Where do you want my parents to go? Into a nursing home? Would the government be able to afford to put my parents in a nursing home? I doubt the government want them to be in a nursing home which is probably overcrowded and/or understaffed as it is. Or will the government pay for a home carers? Is getting home carers easy enough or too much red tape in this too?

There will be a time that my father can't drive anymore, which means I will need to drive both my parents around. I will need to live somewhere close by to them. What if I don't want to live further out? I work in the Sydney CBD. I travel far enough to work as it is. I don't want to have to travel longer to work. Its bad enough that there is not enough parking at the train stations!

With the added stress this is causing my parents, this may shorten their lives.

It will be sad to see our rural areas built up and subdivided but we know it's coming. These are our family homes and we ask that you reconsider this.

A reminder that the election is on in 2019. We may all have to consider who we vote for and if we can find politicians willing to fight with us on this.
