All we ask is that we are treated fairly like our neighbours two doors down from us who are going to be zoned Urban these neighbours could potentially get over 2 million dollars per acre while we get absolutely nothing due to the zoning. We understand and appreciate that a new airport is going to happen and that is not the problem here the problem is that we want to be treated equally so we have enough financial to be able to buy another property of the same value and size so we can all live together as one family again. If we are not given enough money for our property as our neighbours would be given then we will not be able to purchase another property and being in our we cannot afford to have a mortgage this has caused a lot of anxiety in my family because we need to have stablity and also need to know what is going on. We have not been given any information in regards to this except a community consultation that was very poorly run with no information. We plead with the government that they understand this from a personal perspective and look at it with compassion and empathy rather than seeing it as a political stunt. We believe that our property is worth the most out of all the Precinct because without our properties you will not be able to build the infrastructure required for the airport. All that we ask once again is to be treated like our neighbours and everybody is paid on a level playing field rather than somebody two doors down getting two million an acre while we get nothing. I appreciate that you have to do different things and create draughts and policies and procedures for this Airport to happen but please don't take other lives into your hands and use them to better the government. We have been paying taxes since the day we came to this country back in and it is unfair that our properties and hard earned money is going to be taken from us.
