Draft Western Sydney Aerotropolis Land Use and Infrastructure Implementation Plan Jacobs Submission regarding Probable Maximum Flood (PMF) Imagery/Information

Jacobs wishes to make a submission to the Draft Stage 1 Aerotropolis Land Use and Infrastructure and Implementation Plan, which are currently on exhibition.

On Page 39 of the Draft Plan, Jacobs has been attributed as the creator of the PMF layer for the South Creek catchment. Jacobs wishes to advise that it (Jacobs) was not the creator of that layer, and therefore requests Department of Planning and Environment (DPE) to correct this error.

We believe that the confusion may have arisen as a result of Jacobs' work on behalf of DPE in 2016, relating to the early planning phases for the Aerotropolis. It is to be noted that the flood and other data shown in these early reports was provided to Jacobs by DPE as an input to this work, and not generated by Jacobs.

Jacobs requests that the true source of flood data is reflected as the LUIIP is finalised.
