

On behalf of Cricket NSW (CNSW), I would like to commend the Department of Planning and Environment and the other respective local, State and Commonwealth Governments work in developing the draft Stage 1 Plan for the Western Sydney Aerotropolis ('the Plan'). CNSW appreciates the opportunity to provide feedback and looks forward to being a constructive partner in the development of the Plan.

Cricket has a significant presence in Western Sydney with approximately 100,289 participants recorded in the 2017/18 season. The format of cricket in Western Sydney varies from entry level, juniors, pathways, representative, seniors, social to elite men and women's Cricket NSW and Sydney Thunder content at Blacktown International Sportspark and Spotless Stadium. In addition, CNSW will also be relocating some of its administrative, high performance and training facilities from Moore Park to an interim facility at Sydney Olympic Park due to the redevelopment of the Sydney Football Stadium in early 2019.

Cricket is experiencing rapid growth in female participation, far outstripping population growth. The success of the Women's Big Bash League competition has also resulted in rapid growth in female participation and we expect this growth will continue, placing further pressure on sporting facilities across Western Sydney.

As the population of Western Sydney – and hence cricket-playing population – continues to diversify and grow, so will the demand for well-planned and designed cricket facilities.

The Plan provides a unique opportunity to deliver cricket facilities and infrastructure for both the current and growing needs of Western Sydney identified above.

We would like to use this opportunity to request consideration and further discussion of the inclusion of outdoor practice and playing facilities within the multi-sport playing fields allocated as part of the Plan.
