# The new Social Impact Assessment Guideline 2020 for all State significant projects

A new Social Impact Assessment Guideline 2020 (the new Guideline) has been prepared for social impact assessment (SIA) to be applied to all State significant projects. This new Guideline replaces the existing SIA guideline for State significant mining, petroleum production and extractive industry development, released in 2017.

#### What are the transitional arrangements for the SIA Guideline 2020?

The SIA Guideline 2020 now applies to State Significant Development (SSD), including SSD sites, State Significant Infrastructure (SSI) and Critical State Significant Infrastructure (CSSI)<sup>1</sup>. **Table 1** provides high-level transitional arrangements for each of the three phases of the EIA process.

The proponent should continue with the preparation of the EIS in accordance with the DPIE's formal advice. The proponent can apply the SIA Guideline 2020 voluntarily. DPIE can reissue SEARs referring to the SIA Guideline 2020 and may do so if a long time has passed since the SEARs were issued.	2a: SEARs issued *

			2c: Lodge EIS
3	A proponent has already submitted a development application and EIS.	DPIE may, if needed, require additional information on, or assessment of, specified social impacts identified in the submitted EIS, public exhibition submissions, or the Submissions Report, in accordance with the SIA Guideline 2020.	3a: Assessment prior to exhibition
