# Online Complying Development Certificate Service API – Release Notes

# **Overview**

The Department has developed inbound and outbound APIs to facilitate the flow of Complying Development Certificate (CDC) data between the Online CDC Service and the IT systems of councils and private certifiers.

# **Key Features**

The following features are being delivered as part of the Online CDC Service API release:

# Online CDC - Certifier to ePlanning API

The Online CDC Service API provides an inbound connection from a certifier's IT system to the New South Wales Planning Portal and related data repositories.

# **Accept Decline CDC case**

This operation transfers the certifier's decision to Accept or Decline the Complying Development Certificate case from certifier's IT system to the Online CDC Service.

### **Provide Development Specification**

This operation enables the certifier to provide development specifications from the certifier's IT system to the Online CDC Service.

#### **Edit Registered Practitioner**

This operation enables the certifier to update the registered practitioner details from the certifier's IT system to the Online CDC Service.

# **Determination**

This operation transfers the certifier's determination decision on the CDC case from certifier's IT system to the Online CDC Service.

# **Final Plan Submission**

This operation transfers the final plan submitted by the certifier from the certifier's IT system to the Online CDC Service.

#### **Get Documents**

This operation enables the certifier to transfer the documents from the certifier's IT system to the Online CDC Service.

#### Request for Additional Information from Applicant

This operation enables the certifier to request the applicant to upload additional information to the Online CDC service from the certifier's IT system.

# Re-assign CDC case

This operation transfers the certifier's assigning or reassigning of the CDC application to an officer from the certifier's IT system to the Online CDC Service.

# Online CDC - ePlanning to Certifier API

The Online CDC Service API provides an outbound connection from the NSW Planning Portal to a certifier's IT system.

#### **Create CDC Case**

This operation transfers the CDC application created by the applicant from the Online CDC Service to the council's IT system.

### **Edit Registered Practitioner**

This operation transfers the updates made to the registered practitioner details by the applicant from the Online CDC Service to certifier's IT system.

#### **Get Documents**

This operation transfers the documents from the Online CDC Service to the certifier's IT system.

#### Withdraw CDC Case

This operation transfers the applicant's decision to withdraw the CDC application from the Online CDC Service to the certifier's IT system.

#### **Provide Additional Information**

This operation transfers additional information uploaded by the applicant from the Online CDC Service to the certifier's IT system.

All participants (Applicants, Utilities, Agencies, Certifiers and Councils) can view case details, uploaded documents and referral decisions throughout the SC process® State of New South Wales through Department of Planning, Industry and Environment 2020. The information contained in this publication is based on knowledge and understanding at the time of writing (December, 2020).
