As property owners of our forever after home it is devastating to think we have to fight for the home we have built and lived in for 23 years.

We are unimpressed with all of the stressful process that the Western Sydney Planning Partnership has put us through for the past 18 months.

Receiving another proposed planning policy on the 05.12.2019 is ridiculous. This is confirming that this whole Aerotropolis Plan is still up in the air.

Having to attend Council Meeting (Which tell us nothing) is stressful and a waste of time. Writing these submissions and pouring our hearts out is also becoming stressful and tedious.

After investigating and researching our options on relocating, we feel our home and land is not replaceable. We live on ■ acres of well maintained land with a large house, huge shed and pool. We will need to be compensated with replacement value.

Where do you expect us to find another estate with no traffic problems, no noise problems, no people problems and no police problems?!

We are extremely disappointed at what appears to be a very amateur attempt to obtain Kelvin Park Land.

This new proposal separates a group of us to be acquired immediately and a group that lives on South Creek to be worthless and no information on the rest of our Estate.

I personally think the Government has no idea what they are doing. I think you will simply rezone us later when you obtain our land, so I expect to be treated fairly.

- Non-Urban Land – Didn't happen
- 1/1000 Flood Line – Didn't happen
- Government to purchase all of Kelvin Park ???
- All the Land of Kelvin Park to be purchased at the same value ???
