They receive emails advising of meetings that will give them more information. They become hopeful that they may receive some closure (an exact date on when the land acquisition will be happening). They spend the week leading up to the meeting worried, stressed, writing down dot points on questions they would like answered. They don't sleep the night before the meeting.

The meeting happens, they ring me to give me an update and they are devastated because they are no closer in knowing what is happening. They receive no new information, no key dates – NOTHING! All that stress, worry and anxiety for them to be told nothing they don't already know!

They wait a few months, receiving new "<u>Proposed</u> land acquisition dates information" via email/internet, then go through the above process all over again.

How much more can my parents take? Is this fair?

My parents aren't getting any younger – they do not need this stress. They were meant to live here forever after. I worry about them constantly. I call them every day just to make sure they have slept ok and are not overly stressed while driving to work, shops etc. I send messages reminding them to look after their mental health.

Every weekend I hear about how they have just spent "three hours" driving around suburbs to try and find a replacement for what they are about to lose, but to no avail. Nonetheless, they spend the next week on the internet, hoping something new pops up that they could potentially consider. Yet, how are they supposed to plan where to go next when they cannot find anywhere that matches what is about to ripped out from beneath them?! Or, have a time frame of when the acquisition will actually take place?

My Mum and Dad have worked hard everyday of their lives to have ■ acres of bliss – They deserve to be compensated fairly for what they are about to lose!

As a former resident of Bringelly, I confirm I will never get over how this has affected my Mother and Father and just how heartbreaking this entire process has been.

Ask yourself this – How would YOU feel if this was your Mother and Father?!
