I would like to receive a response for my submission.

I have lived at [REDACTED] Bringelly for majority of my life. I did not think my parents would be forced to move out due to the acquiring of their property. My parents have been very stressed as there is no certainty on what is going to happen to our home. It saddens me to see my parents be affected emotionally and mentally. Every day becomes more and more stressful with the uncertainty of what will happen to our land.

Our home is an ideal location for work, family, and overall lifestyle. If our property is acquired then we must find another property to move to. To find somewhere equivalent with the 5 acres we already have will mean we have to move out further. This will add extra cost and time when travelling to work, to visit family, to do our grocery, and affect our overall lifestyle.

My parents have been travelling to various areas to find a property equivalent; however, properties near equivalent are not developed in the sense that they do not have town water, no streetlights, no close by shopping centres and have no internet access. This will affect our overall lifestyle dramatically as in Bringelly, we do have access these facilities.

My parents have worked very hard to have what we do, and it is unfair that it is being taken from them through acquisition. We do not know when everything will take place, they are not updated on the current situation or if we will be fairly compensated.

- I do not agree to the South Creek Precinct.
- I do not agree to the re-zoning land environmental/recreational and leaving it under private ownership to achieve more green space at the expense of the landowners and no expense to the government
- I do not agree with the outdated flood study being used for this proposal
- I do not agree on the Thompson Creek Proposal on outside flood affected zones when state government own 114 hectares of OTC government land

I do hope that my parents are fairly compensated with whatever is to happen so this assists my parents in finding a property close to equivalent to what they have now on Kelvin Park Drive.

It upsets me to see how this situation has drastically affected their emotional and mental wellbeing. I do hope more information is provided to ease my family and I as if our property is not acquired and zoned as environmental and recreation, you will destroy us financially as our property will be devalued.
