Growing up, I lived at and still visit my parents almost every day. Never did I think my parents would be forced out of their home, and my only childhood home. The plans for the Western Sydney Aerotropolis Proposed Land Acquisition of my parents' land has dramatically affected their health. They are constantly stressed as they are kept in the dark with what is to happen with their property. Every day is more and more stressful as there is no certainty on what will happen with their property. My parents have always and still do work very hard – they are not getting any younger, they do not need this stress.

I have recently become a father, and it saddens me to know my child will never be able to experience the beautiful 5 acres I grew up on if their land is acquired. My child will never be able to have the luxury of running around and playing on 5 acres, gardening and planting trees, and enjoying the home here my family have.

My parents' property is an ideal location for their work, family (to travel to me in Oran Park), and overall lifestyle. If their property is acquired, it will be very difficult for them to find something equivalent, as traveling further out for a 5-acre land will mean additional costs and time for travelling. They have called me every weekend as they spend hours travelling to and from different places attempting to find something equivalent to what they have; but it is impossible. Nothing will ever compare to the home they have here on

It is unfair that the property is being taken from them through acquisition. I do hope they are fairly compensated as if their property is not acquired and zoned as environmental and recreation, my parents will be destroyed financially as their property will be devalued.

- I do not agree to the re-zoning land environmental/recreational and leaving it under private ownership to achieve more green space at the expense of the landowners and no expense to the government
- I do not agree on the Thompson Creek Proposal on outside flood affected zones when state government own 114 hectares of OTC government land
