I have grown up at [REDACTED] and never did I think my family and I would be forced out of our property. The home we have here is an ideal location for work, family, and overall lifestyle. The acquiring of our land has caused major stress on my family and I as to move to another property with the [REDACTED] we have in Bringelly will require us to move out further. To move out further will cause additional costs in travel when heading to work, visiting family, going grocery shopping etc.

My family and I have no certainty of what is to happen, and it causes extreme stress. We do not know when everything will take place, they are not updated on the current situation or if we will be fairly compensated. It is already not fair that my family and I are being kept in the dark about what is going to happen. My parents travel to various areas looking for a new property but are uncertain of the compensation they'll receive so they do not know what kind of property to even look for!

My parents have worked very hard their entire lives and they are not getting any younger – they do not need this kind of stress. It hurts me to see how this entire situation has affected their emotional and mental wellbeing. I do hope more information is provided to ease my family and I as if our property is not acquired and zoned as environmental and recreation, you will destroy us financially as our property will be devalued.
