I would like to receive a response for my submission.

As the owner of [REDACTED] Bringelly, I am absolutely devastated that my home is being taken from me. From the beginning, my property was zoned as non-urban which was upsetting to know; however, it only became worse from there on. After this it was stated my property will be acquired and will be zoned as environmental and recreation which has only caused more stress on my husband and I. The Western Sydney Aerotropolis Proposed Land Acquisition has drastically affected our health, causing our emotional and mental health to decline due to the stress we have incurred.

It is not fair that the government has decided whose property is and is not valuable. My property is valuable, it is not a house, but a home. An ideal location for work, family, and my overall lifestyle. I do not need to travel far to complete grocery shopping and complete daily tasks. [REDACTED] [REDACTED] from when the first plans of my property came out where we were going to be zoned as non-urban. [REDACTED]

[REDACTED]. To find a property near equivalent will have me and my family travelling further increasing time and costs. This is not ideal, especially for my husband and I who are not getting any younger.

Every day is more and more stressful as my husband and I do not know if we will be fairly compensated, so we are unaware of what kind of property we need to search for. Regardless, we will be disadvantaged as a result as we must move from our current ideal location with our beautiful 5 acres. It saddens me to know that the home we were supposed to grow old in, that my husband and I have worked so hard for, will be taken from us. The properties further out we have looked at are also not developed in the sense that they do not have town water, no streetlights, no close by shopping centres and have no internet access. This will affect our overall lifestyle dramatically as in Bringelly, we do have access these facilities. There is no suburb equivalent [REDACTED]

- I do not agree to the South Creek Precinct.
- I do not agree to the re-zoning land environmental/recreational and leaving it under private ownership to achieve more green space at the expense of the landowners and no expense to the government
- I do not agree with the outdated flood study being used for this proposal
- I do not agree on the Thompson Creek Proposal on outside flood affected zones when state government own 114 hectares of OTC government land

I do hope that my husband and I are fairly compensated for the land acquisition. We would like to be able to re-purchase and equivalent property to the [REDACTED] acres we have. The Green Spine is necessary for the development and is therefore valuable and should be purchased.
