Simply!!!! •I strongly oppose rezoning my property to any Environmental zone...so NO environment zone! •If you need to change that zone to Environment then you can do that after you purchase it from me. •We are not there to create Greenspace to balance the lack of Greenspace in the Oran Park Perich development *You have The Rossmore Grange to use for Greenspace if needed...that is more than enough. •To have lots of Greenspace next to the airport is dangerous for Bat and Bird strikes •In the recent floods we had no major flooding and

once the creek is cleaned and dredged it would completely be insignificant and you can still build on here •The way in which your department has dealt with us landholders has been horrible! When questions are asked no real answers are given. *How did the tree huggin policies help the recent fires? They didn't!
