The "Draft Western Sydney Aerotropolis Plan" contains an oval shaped "Regional Parkland" for investigation, covering much of the Kelvin Park estate at Bringelly, as pictured below.

I strongly object to this consideration, as do all those who own and live on the property above.

The fact that you have arbitrarily highlighted land on paper demonstrates total ignorance with regards to peoples' democratic rights, economic wellbeing, undue stress and duress, and a complete lack of knowledge of the region.

We purchased our property 26 years ago and signed a contract which gave us certainty about the land use. There are currently three generations of people living on the property above. What you are proposing will forbid any future home rebuilding on this property, rendering the land barren and desolate over time. This will make it impossible for me to exercise my democratic and natural human right to sell the land. It will significantly disadvantage the children who live there and their right of inheritance.

My parents fled such a regime that confiscates assets and land through creative and mischievous methods covered by the veil of "law". What you are proposing and attempting to sneak through is something practiced by rogue regimes, to expropriate property. An example of this is the theft of Palestinian lands where homes are demolished, and the owners forced off their land; or regimes in South America who confiscate land from the indigenous peoples to resell to wealthy farmers and corporations; or where regimes force people to sign away their properties during wars of aggression. And yet, we are not at war and I did not think we are ruled by a regime.

This is nothing less than land theft over time. You cannot renege on a contract at my cost, and at the cost of multiple owners. Contract laws forbid such practices where one party is disadvantaged.

I therefore implore you to reconsider and:

- Maintain the rezoning as marked in the document as "Mixed Flexible Employment & Urban Land";
- Not rezone my property to a lower level to my economic disadvantage and wellbeing, and to the economic disadvantage and detriment of those living on the above property and surrounding properties.
