My home is not connected to town water and will be for the foreseeable future I rely on rain tank water for my daily use, this is constantly contaminated by dust raised by main road and airport construction companies and will be prone to airplane exhaust fumes drifting over my home contamination in my water tanks . The residents of Bringelly are not land banking like large investors, like myself many have been here for many years this is our life our future give us some resolution. Now is the time for the planning authority to end its indecision and give piece of mind and ability to plan for the future to all the residents in the Dwyer rd precinct. Zone us industrial let all land owners have the clear opportunity to plan for the future.
