Submission: My husband and I have resided at [REDACTED] Kemps Creek for a combined period of 65 years. We purchased three acres of land to enjoy the peaceful atmosphere by spending most of the time outdoors. During this period we have been able to enjoy clean, living raising children, growing vegetables, rearing animal and welcoming the privacy of neighbours not being too close. Our daughter, her husband and our grandchildren also reside on this property and spend every opportunity they can to enjoy the open spaces. Unfortunately we will no longer be able to do this in the immediate future with the airport next to us, planes flying over our homes and the aircraft noise levels above 25 – 35 ANEC – noise levels way above acceptable residential habitation. The whole Aerotropolis project has impacted severely on our health. The stress and anxiety of not knowing definite outcomes or answers have resulted in me having a heart attack and my husband a stroke. We also have major concerns for our daughter, son in law and grandchildren who reside on the property. Our daughter has lived here for 42 years and her husband 15 years. We encouraged them to stay and help us as needed and we in turn help them by looking after our grandchildren as they both have substantive positions and there was no need for them to ever move... now the construction of the airport also means they will need to relocate as the lifestyle they are used to will change significantly with increased road traffic and again aircraft noise levels way above that of acceptable residential habitation. Both are suffering from high blood pressure caused through stress of not knowing where their paths in life are going to lead. The uncertainties of where they will move to has affected their children as well. How do you tell a child that they will have to leave their school, karate, swimming squad and all their friends as we cannot afford to buy a property similar to the one we live on in close proximity to school and sporting venues? Their children are involved in various sporting activities, leadership programs, have a wonderful circle of friends and most importantly

the freedom of having acreage to run around in. . Lack of information from the Government and the devaluation of our property due to the proposed "Green Zone" have caused major upsets for me and my family, not to mention our adjoining neighbours. Our health and wellbeing has now been taken over by stress, anxiety, sleepless nights and major concerns over where to live?? Local Real Estate Agents have indicated that properties with proposed E Zoning have lost significant value, in particular the area where we live which has lost value due to aircraft noise and will essentially be unsellable. We strongly oppose the decisions in relation to our property being part of the proposed Environmental/Recreational Zoning and the outdated flood study being used as the basis for this decision. We were also misled by members of the State Government Planning Department at an information session about the current flood zoning for land along the South Creek. As said previously I have lived here for 65 years and we are yet to flood. Should Government continue to want to zone our land for environmental and recreational use we can only hope our land is acquired prior to the opening of the first runway in 2026, and the land purchased at a fair and reasonable price for its best use i.e. Industrial. We can only move forward if the Government finds it in their hearts to deliver whilst we still have the opportunity of buying something similarly priced and keep a family together. Looking forward to a favourable answer
