I'm a resident from [REDACTED] where our property has been placed in the South Creek Precinct.

If we are re-zoned, we will loose everything. My husband and I will have nothing, our property is our investment for the future.

We do not object to the new airport but object to the proposed re-zoning of our area, our home and land.

We need to be treated fairly and with dignity, as the government is advertising on how beneficial this development would be to all land holders and for us to find out that it is only for some.

We all pay land rates and with the flick of a pen you will change the zoning of our properties, rendering our properties in the South Creek precinct relatively worthless in comparison to the properties across the road in the Aerotropolis Core.

We should be fairly compensated with equal value of other land owners which are in the aerotropolis core zoning which is across the road from our property.

We envisage that if we have to sell our property for a fair amount of money so that our blood, sweat and tears was not for nothing.

If we had to leave because of this proposed new re-zoning, we MUST be compensated so that we could obtain the same improvements and dwellings, mirroring our current property now.
