**Content:**

I am a Land Owner & Taxpayer from [REDACTED] with a young family.

We purchased our five acres just over 10 years ago with a large mortgage, working hard to make a life for our family. We are now concerned for our future and our children's future due to all these stage 1 proposals placed in our area regarding the Aerotropolis Core. We have spent a lot of money in renovations to improve our property and its value. We are not going to be compensated for this if we are re-zoned and de-valued as mentioned in some NSW Planning strategies.

The PMF is highly overstated and incorrect. We have NEVER seen flood rise as high above Thompson Creek as stated in council plans and charts. It even states as a large fire hazard which is incorrect as we have no trees on our acres.

Our property consists of flat land and minimal trees along the creek only, which could be cleared of overgrown vegetation if maintained by council. Thompson Creek has NEVER been cleaned by the council since we have lived here and longer beyond this (Over 30 years - as I've heard from neighbours). This new proposed South Creek precinct will make our land worthless. They are taking all of our non-flood prone land and using it for greenspace which could be used for the Aerotropolis Core as equivalent to our neighbours across the road.

The Green Space is over 2 kilometres wide in some places on this proposed map, and flooding is nowhere near this span. Pipes could be easily put underground to create a better looking business park in all areas-especially along the short span of Thompson Creek " branched off from the major South Creek.

It has taken a massive amount of stress on our lives, our family and children. We are unsure as to what will happen and how it will affect us. The government MUST take our lives and future into consideration before implementing such massive changes.

We must be compensated financially before any agreements come into place so that we are able to relocate and continue our normal lives. We understand the airport is important - so hence our land which is so close to it - and surrounds, is MUCH MORE valuable than it seems the Government will offer to us!

We await your favourable response to these submissions and must enforce the importance of having the residents of [REDACTED] interests at hand before such drastic plans and stages are put in place.
