My name is [REDACTED] and I live in Bringelly NSW (within the area that is potentially being rezoned as Agribusiness)

Firstly I need to ask what this rezoning means. I have contacted many politicians including our local MP, and no-one has been able to fully define what this zoning means. They have been unable to explain fully the repercussions of the rezoning on property prices in the area. (already I know of two families who have had vendors withdraw offers on their properties and counter offer with drastically reduced amounts due to the uncertainty of the rezoning)

Even without full clarification as to what the rezoning actually means, I feel it is a poor choice for this area.

I object to this rezoning for the following reasons:

1. The area marked for rezoning to agribusiness has extremely poor soil and no water supply, rendering it useless as agricultural land.
2. The area is in such close vicinity to the proposed Badgery's Creek Airport that it would be under flight paths that could potentially cause contamination of crops and live stock through jet fuel emissions.
3. The area is in such close vicinity to the proposed Badgery's Creek Airport that it would far better suited to be rezoned as Industrial or Commercial.
4. If rezoning to Industrial or Commercial is not an option for this area, then it should be left with its current zoning (large residential).

I hope that you are able to help me have my voice heard. We have lived in this area for many years and have enjoyed the relaxed lifestyle. We are now living in limbo, not really knowing what the future holds and what will become of us if rezoning to agribusiness takes place. We are stressed and nervous and worrying about the future.
