If your department goes ahead and rezones our property we will lose everything.
My husband & I will have **NOTHING**. Our property is our investment for our future.

I feel that the NSW Planning & NSW Government are turning us into **REFUGEES**.
BEENING FORCED TO LEAVE OUR HOMES! INSTEAD OF OUR COUNTRY!

As an Australian land owner in this Aerotropolis core development we need to be treated fairly and with dignity.
As the government is advertising on how beneficial this development would be to ALL Landholders and for us to find out that it will **only** be for Some.

NSW PLANNING & NSW GOVERNMENT ARE IN MY EYES NOW TRYING TO PLAY GOD.

We are all currently zone RU4 in our street at [REDACTED].
We are all paying the same rates and with a flick of a pen you will change the zoning of our properties rendering our properties in the South Creek Precinct **relatively worthless** in comparison to the properties across the road in the Aerotropolis Core.
