We as landholders have great concerns, with regards to the draft plans of Aerotropolis core for the Badgery creek airport.

We feel the government has not been transparent and fair with the entire proposed submission.

We have been worried, anxious, and have not been sleeping well since plans were released with little information to exactly what does our zoning mean?

We were also surprised to find out floodplain rezoning was restricted in 2012 without public consultation.

[REDACTED] and have seen flash flooding's due to the lack of maintenance of the creeks in the area.

However, our property has never been flooded and has not been affected by flooding when flash flooding's have occurred.

Current daft plans show our land has been affected and zoned half green space and half future residential.
