"Mum when are they coming to take our house " these boys may be young but they are not stupid and this is effecting them mentally. They don't want to move they want to keep their huge backyard that they play in everyday but unfortunately we have to go and i am hoping that we will be given the financila pay out to buy a property of the same size without having to get another mortgage. We have paid taxes our whole life and worked so hard to have what we have and we do not want to start all over again. I have not had a good night sleep since i have found out about this and i am suffering severe anxiety and uncertainty for my self and family. [REDACTED] we are feeling very uneasy and anxious about our future. I cannot express enough how scared we are that we will be ripped off by the government and have the rug ripped out from underneath us. We own the most valuable land withing the aerotripolos which will end up being the main infrastructure for the airport. We are not non urban pricing...we are worth the most in all the precincts and we will not allow this to tear our family apart and cause angst that is extremely unnecessary and could have been avoided with better planning and more communication. I hope that you look at this as if it was you or your family going through this and think how you would be feeling. Put politics aside for one moment and think with compassion. All we want is to be treated as our neighbours will be in the urban zoning as we did not ask for this.
