I am writing on behalf of the owners of the two properties detailed above., [REDACTED]

The properties, whilst having a different company owning each, the two companies have common shareholders and directors behind them.

The properties have been held for many years with [REDACTED] being owned and operated as a landfill and recycling centre since 1989 and the adjoining [REDACTED] being held for storage of equipment and future expansion of the recycling operations.

[REDACTED] which operates as a landfill, quarry and waste recycling operation, directly [REDACTED] people and [REDACTED] to substantially upgrade its operations to process additional waste streams. This would result on a likely doubling of the employment numbers.

We note that the various plans for the development of the area being:

- Western Sydney Aerotropolis, Land Use Implementation Plan and
- South West Priority Growth Area Plan,

are unclear as to a defined boundary and inclusion of the above two properties.

We submit that as the properties currently provide substantial employment and with the proposed development [REDACTED] a significant increase in employment opportunities, the properties MUST be included the current plans.

We seek clarification and confirmation that the subject properties are included in this development as they have the ability to offer great opportunities to contribute positively to the orderly growth being envisaged by this massive infrastructure development.
