It is very disappointing to learn about this public exhibition several days after it has closed. As the Cumberland Plain Conservation Plan is the major conservation plan being developed for Western Sydney it is vital that it also reflects the aspirations for its survival across the entire Sydney Basin community. We should all be concerned that what remains of this important native vegetation and the wildlife it supports is given the maximum protection possible. While the Plan will identify how any impacts to biodiversity from projected growth in Western Sydney will be addressed, we have already seen the level of development occurring and fear for the future of the natural values under further onslaught from population pressures.

I hope that you will accept my comments and can reassure me that further input will be possible on the conservation plan. I certainly hope that a fair balance will be found in delivering positive environmental outcomes by avoiding over development during the 37 years' life of the plan and applying the well-founded principles of Ecologically Sustainable Development.
