My covenant covers 2.2 hectares of mature Cumberland Plain Woodland that I have owned and conserved since 1960.

I have recorded over 150 different species of birds, including water birds, on my property and send a monthly list to the Cumberland Bird Observers Club of which I am a member.

Two natural water courses meet on my property that subsequently drain into First Ponds Creek and eventually into the Hawkesbury River Estuary.

We have already lost over 90% of the Cumberland Plain Woodland.

No more loss of our precious trees as offsets for developers. They are carbon sinks and oxygen producers. They also make rain and prevent drought.

Developers have sold our topsoil and our trees as woodchip.

They have polluted our catchments with their storm water basins.

Ecosystems are drowning in water turbidity and pollinators that are essential to our food production have no clean water

to drink.

Instead of using our precious remaining woodland as offsets for developers, make them pay for the devolution and ecocide they have achieved during the last terms of NSW Government.
