The draft Mamre Road Precinct rezoning package was exhibited between 18 November to 18 December 2019. The rezoning package proposed changes to the State Environmental Planning Policy (Western Sydney Employment Area) 2009 (WSEA SEPP). This included a proposed rezoning of the Mamre Road Precinct to facilitate industrial development.
