# Design and Place State Environmental Planning Policy (SEPP)

Design Matters National is Australia's leading industry organisation which represents building design professionals. We work closely with federal, state and local government to ensure the quality of building design is maintained at the highest professional and ethical standards, and we are accepted among government agencies, universities/TAFES and industry groups as a thought leader on building design issues.

We recently amalgamated with the Building Designers Association of Western Australia (BDAWA), and the Building Designers Association of the Northern Territory (BDANT) with over 2200 members nationally. It is imperative that 'suitably qualified design professionals' is defined to include qualified Building Designers to ensure no restriction of trade for these professions or adverse anti-competitive measures.

To avoid potential risk to Building Designers, we also request that 'suitably qualified design professionals' be clearly defined in the body and glossary of the proposal at the outset.

The proposal does not clearly support Building Designers designing and documenting buildings exceeding small residential projects, which is not in line with the profession's scale of work which exceeds these small projects. Qualified Building Designers are educated to professionally design and document a range of buildings (including mixed use) which needs to be supported and clearly outlined in this proposal.
